

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the HANCOCK WHITNEY CORPORATION EMPLOYEE WELFARE FUND, EIN 64-0693170, Plan No. 501, for period 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

HANCOCK WHITNEY CORPORATION has committed itself to pay certain self-insured Medical, Stop Loss, Short-term Disability, and Severance claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with AMERICAN HERITAGE LIFE INSURANCE COMPANY, AMERICAN BEHAVIORAL BENEFIT MANAGERS, LLC., FEDERAL INSURANCE COMPANY, METROPOLITAN PROPERTY AND CASUALTY INSURANCE CO., PRUDENTIAL INSURANCE COMPANY OF AMERICA, VISION SERVICE PLAN, HUMANA INSURANCE COMPANY OF NEW YORK, HUMANA INSURANCE COMPANY, METROPOLITAN LIFE INSURANCE COMPANY, HEALTH ADVOCATE SOLUTIONS, INC. to pay Medical, Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Business Travel Accident, Legal, Critical Illness, Cancer, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$6,139,888.
